






Work card 5 3R (REDUCE, REUSE, RECYCLE)

Work card 7

Crisis management simulation from an ecological perspective

The task is to develop a strategy for dealing with the crisis, minimising the negative impact on the environment, and maintaining the operational stability of the company.

Crisis scenario - Extreme Weather Phenomenon: "EcoStorm"

The simulation involves a company called "EcoTech Solutions", specialising in the production of ecological technological solutions.

- 1. You receive meteorological information about the upcoming storm, called "Eco Storm". Forecasts indicate that the storm will reach your area within 48 hours.
- 2. Each management team must take immediate steps to secure employees, company infrastructure and critical data: *What measures will be taken to minimize the impact of the storm?*
- 3. Eco Storm becomes more severe within 24 hours. Decisions must be made regarding the evacuation of employees: *What security procedures will be implemented?*
- 4. Eco Storm hits your location, causing significant damage to infrastructure, stopping production and disrupting deliveries: *What actions should be taken to restore normal functioning of the company?*
- 5. Organize effective communication with employees, customers, suppliers and other stakeholders: *What communication channels will be used to maintain stakeholder trust?*
- 6. After the Eco Storm has passed, the reconstruction process must begin: What steps will be taken to quickly restore normal operation of the company?
